This letter is to let you know that Dublin Array, a project to construct an offshore wind farm on the Kish and Bray Banks, has begun a period of public consultation. The aim of this process is to inform the public that an updated Environmental Impact Statement and a Natura Impact Statement to Inform Appropriate Assessment have been prepared in respect of the above proposed development as part of an application originally made to the Minister for the Environment, Community and Local Government in 2006 for the necessary Leases to carry out these works on the Foreshore.

The updated environmental information together with a copy of all relevant plans, drawings and photomontages may be inspected from 9th April 9th to 1st June 2013, free of charge, at the following locations during normal opening hours (for a full list of opening hours, see www.dublinarray.com):
